Anthony Wayne Local Schools Operational Funding Overview

School districts and other organizations use the strategic and facilities planning process to reflect upon their progress, gather feedback and plan for the future.

Over the past year, Anthony Wayne Local Schools (AWLS) partnered with Planning Finding Leaders, an educational consultant and The Collaborative, a local architecture firm to support the District's future planning.

As a part of this process, the District consulted with a variety of stakeholders to gather feedback on the improvements our community would like to see in our schools.

The result of this work is the <u>Anthony Wayne Strategic Plan</u> and the <u>District Master Facilities Plan</u>. Both were approved by the AWLS Board of Education during the 2022-23 school year.

In order to accomplish the goals identified in the Strategic Plan and move forward with the projects detailed in the Facilities Master Plan, the Board voted to add a 2.6-mill Bond Issue and a 2.9-mill Operational Levy on the November 7, 2023 ballot.

This document is intended to share how the District determined the request amount for the Operational Levy. More information about funding needs for the Facilities Master Plan is available in the <u>Facilities Master Plan Overview</u>.

Academic Intervention

Over the last three years, the District has worked to redefine our K-12 academic intervention services. With the use of ESSER funds, the District hired six teachers to serve as instructional coaches to continue the development and implementation of academic intervention programs in our school buildings.

In doing so, the District has developed a framework for integrating comprehensive systems of student supports to address the needs of each individual student. In addition, the District hired tutors for each building as a part of this comprehensive system of support to maximize individual student success. With the ESSER funding coming to an end, the District will need additional

operational funding to continue to provide these academic intervention services to students in need of additional academic support.

The District summer school program provided a variety of academic interventions and supports to students who needed their learning to continue into the summer. From high school credit recovery options to targeted support to students in the lower grades, these services are essential to ensuring our students meet their learning goals.

All-Day / Every Day Kindergarten

During the Facilities Master Planning Process, parents shared that they wanted Anthony Wayne to implement an all-day, every-day kindergarten program. Studies have shown that a full day of instruction in kindergarten, gives students a stronger academic foundation in preparation for first grade - particularly in the areas of reading and mathematics. A full day program also offers more flexibility in accommodating the varying academic needs of students at all developmental levels.

The full day experience also allows more time to practice problem solving skills, and develop the physical and social skills that are needed to prepare them for the more structured school experience that begins in first grade.

Special Education Costs

Over the last several years, the District has experienced an increase in the number of students needing specialized services for their educational needs. These services often include the need for additional staff and/or specialized services provided by an outside agency to meet the students' academic needs, and to ensure that the District remains in compliance with state and federal laws. The District needs additional operational funding to offset the significant increase in the purchased services required to properly educate our students receiving special education services.

Additional operational funds are needed to hire additional core subject area teachers to reduce class sizes, provide increased support and expanded instructional opportunities for individual students with a variety of academic needs, and allow for an overall improved learning experience for all students.

Mental Health Intervention

Mental wellness is critical to the success of the student in school. The National Association for School Psychologists reports that 20% of K-12 students will experience a mental health issue during this school year. Anthony Wayne Local School has also has seen an increase in the number of students needing prevention and intervention services. In response, the District has hired personnel to help address student mental health issues. Additional operational funds are needed to continue to be responsive to our students' wellness to ensure they are in attendance and ready to learn.

School Safety Initiatives

The safety of our staff and the students in our care is of utmost importance. The District will continue to seek grants and other safety funds made available to schools, but their availability is not guaranteed. Operational funds support the District's ability to provide school resource officers and security personnel as well as the development of and implementation of threat assessment teams, multidisciplinary safety teams, safety protocols, and safety programming in the buildings.

Purchased Products Cost Increases

The District has experienced rising prices for gasoline, utilities, and other purchased products that allow our students to be transported to and from school and be educated comfortably during the day. While the District strives to find ways to minimize the increases in this area (cooperative buying programs, etc.), the new operational levy will be used to offset this rise in costs to educate the AW students.
